CONSTITUTION OF THE MEN'S CLUB
OF FOREST HILLS

As Amended November 24th, 1924.

I

NAME. This Organization shall be called
"The Men's Club of Forest Hills."

II

OBJECT. Its object shall be to welcome
men coming into the community, to promote
good fellowship and all that stands for the
best interests of the community.

III

MEMBERSHIP. Any man in sympathy
with the objects of the Club may become a
member, upon recommendation of the Mem-
bership Committee and by a vote of the Club.

IV

OFFICERS. The officers shall be a Presi-
dent, Vice-President, Secretary, and Treas-
urer, whose duties shall be those usually per-
taining to their offices.

V

COMMITTEES. There shall be two com-
mittees of three or more members each, ap-
pointed by the President: (a) A Membership
Committee whose duty it shall be to interest
the men of the community, especially the new
comers, and secure their cooperation in the
objects of the Club; (b) An Entertainment
Committee whose duty it shall be to provide
suitable lectures, entertainments, etc.

VI

MEETINGS. (a) Meetings of the Club for the election of new members and other business shall be held at the call of the President. (b) The Annual Meeting shall be held on the last Monday in May of each year.

VII

DUES. The dues shall be two dollars a year.

VIII

AMENDMENTS. This Constitution may be amended at any meeting by a two-thirds vote of those present, provided notice of the proposed amendment has been given at least a month in advance.

IX

QUORUM. Twenty members shall constitute a quorum.

TEN YEARS OF THE MEN'S CLUB

The first meeting of the Men's Club was held at the Church in the Gardens on December 21st, 1913, following a discussion among some of the men in the church as to the advisability of forming such a club for the benefit of the community. The following members were present at this organization meeting:

The next meeting was held Jan. 12, 1914, at which Mr. Chas. H. Scammell was elected the first president.

Regular monthly meetings were held with interesting talks by various members and outsiders such as has been the practice ever since. Owing to the first annual election being held in May as provided in the constitution, and as the officers had been in office only a short time, they were unanimously re-elected for the following year.

At the May meeting, Mr. Scammell made the suggestion as coming originally from Mrs. Scammell, that Forest Hills Gardens have a Fourth of July pageant, and that the Men's Club start the plans for such a celebration. Mr. Wessman was appointed the chairman of that committee, and it was thus, through the initiative of the Men's Club, that our famous Fourth of July celebrations were inaugurated.

Within a year the membership had increased to 53.

On April 9, 1915, the Club held its first Ladies' Night at the Gardens Club at the foot of Ascan Avenue, giving a dramatic performance under the direction of R. J. Cole and Harvey T. Warren.

Mr. Scammell was appointed chairman of the second Fourth of July celebration.

The minutes show many enjoyable evenings spent by the members in initiating the new members, which custom seems to have passed out of existence.

On March 17, 1916, the Club celebrated its second annual Ladies' Night with the presentation of the one-act fantasy, "Shades of Night," produced by Mr. Warren.

On May 20, 1916, the members made a pilgrimage to Sing Sing to inspect the prison, at the invitation of the Mutual Welfare League of Sing Sing.

On December 15, 1916, the members were the guests of the Gardens Players at their annual Fall Production.

At the meeting on May 11, 1917, the members were very much interested in a talk by Captain McClintock, a Kentuckian, who had served in a Canadian Regiment in the front line trenches in France, and who was on furlough because of wounds. His description of the conditions which the soldiers were undergoing was most vivid.

In the summer of 1917 the Club held a special meeting to arrange details with the Rainbow Committee of the Community

Council for the entertainment of the soldiers of that Division who were to be the guests of the community just prior to their leaving for France. Fully twelve hundred men were entertained at that time. It was a most wonderful experience for all those concerned, and will always remain one of the most vivid memories of the war time.

In November 1917, the feature of the meeting was a talk by Mr. Mooshek Vorperian, an eighteen year old Armenian who had recently escaped from the Turks, crossed Russia and Siberia, landing on the west coast, and then coming to New York. Several hundred dollars were collected that evening and presented to the boy. Almost a year later, he committed suicide.

At the Ladies' Night on March 15, 1918, held at the Inn, Mrs. Duryea spoke most interestingly of her war relief work during three and a half years behind the fighting lines in France. Two hundred members and guests attended the meeting. A total of over \$1200 was raised to assist in the Duryea War Relief Work.

At the meeting on December 9, 1918, the Club had the pleasure of an address by M. Marcel Knecht, member of the French High Commission, a French soldier under Marshal Foch, and a man held in high esteem by the French government.

On January 10, 1919, the Club accepted an invitation to attend a meeting of the Women's Club to hear an address by Lieutenant de Wierzbecki, a member of the French High Commission.

On April 2, 1920, the Club suffered a very severe loss in the death of its president, Mr. Rowland H. Smith. The Club and the Church in the Gardens joined in a memorial service at the Church on April 18. Addresses were made by Lawrence F. Abbott, Dr. David Latshaw and other citizens of Forest Hills and New York upon the exalted character and great public service of Mr. Smith.

On March 21, 1921, the members were given a most interesting analysis of the failure of the Bolshevik regime in Russia by Colonel Kalpaschnikoff.

On October 7th, 1921, the members were treated to a most enjoyable contest of twenty Edisonian questions which created a great deal of merriment and interest, and might be emulated at a future date.

In November there was a very interesting talk by Mr. Noel Sargent, M. A. on the "Open Shop."

In November Mr. Samuel Crowther, collaborator with Henry Ford in his autobiography, gave us a most enjoyable talk on that interesting personality.

Colonel Arthur Woods addressed the meeting in January on the subject of the President's Committee of Unemployment in Washington, and gave many of his experiences as Police Commissioner of New York City.

In March, 1922, our neighbor, Doctor Van Manning, gave us a most interesting talk on the history of petroleum, and at the April meeting which was Ladies' Night, we had a most

interesting lantern slide lecture by Mr. Chubbuck of Philadelphia who traveled most extensively in the Orient.

On April 27th, 1922, a highly enjoyable evening was spent in listening to Mr. Kermit Roosevelt who told us many things about his trip to South America with his illustrious father, and the discovery of the River of Doubt.

In November, 1922, the Club was very much interested in a talk by Lieutenant Boris Brasol, a former officer of the Russian Imperial Guard and one of the three surviving officers of a total of one hundred and seven. His revelations of Soviet misrule and four years of communistic terror were described as only a native Russian could tell of them.

In February, 1923, Mr. Frank J. Sprague, one of the most eminent electrical engineers of the times, described most interestingly the development of the electrical industry as applied to horizontal and vertical transportation.

Mr. Floyd Parsons, Contributing Editor of the Saturday Evening Post, told us of many of his interesting experiences, at the May meeting.

In the winter of 1923-24, the Club depended entirely upon local talent and enjoyed a number of entertaining and instructive addresses. Among the members of the Club who spoke at the meetings were:

Mr. Lyman B. Stowe spoke of his visit to the clinic of Emil Coue at Nancy.

Don Marquis gave us a most enjoyable evening by reading from his Works.

Mr. Adams spoke on the subject of banking and distribution of securities.

Mr. Nugent Fallon on importing and its relation to foreign exchange.

Mr. J. V. L. Hogan on the subject of Radio.

Doctor Corscaden on the use of radium. At the same time we were addressed by Doctor Barker of the U. S. Radium Corporation.

Doctor Casamajor on the subject of Primitive Personality.

At the meeting in the home of Mr. Hanavan on May 28th, 1924, there was staged an actual meeting of the directors of the Gardens Corporation so that the members of the Club might see some of the problems that were presented to the corporation and how they were solved.

At the first meeting of the season of 1924 held on October 20th, our own members described their adventures during the summer, and Mr. Mays told of the results of the Japanese earthquake as he had seen them shortly after it had occurred. Mr. Gordon told of the meeting of the Bar Association in London, and Mr. Holch described the beauties of Denmark.

Judge Moore gave a most interesting talk on the real things of life at the meeting in November, 1924, and Mr. Barr of the Men's Club in Pelham told of the wonderful results they had achieved in the way of civic activities.

In December Mr. Boyden Sparkes told many interesting anecdotes of his experience in "Campaigning with Dawes" just previous to the recent election.

Mr. Stowe gave us an interesting talk on the delights of the Pacific Coast.

The minutes of the Club show many interesting talks and lectures all through this period of ten years, which, in addition to the part taken in community life by the Club, have justified its existence, as is also proven by its increasing membership, which is now 150.
